**NOTICE OF RELEASE AND RELEASE OF SECURITY  
INTEREST IN TRADEMARKS**

THIS NOTICE OF RELEASE AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of July 30, 1999, by THE SUMITOMO BANK, LIMITED located at 555 California Street, Suite 3350, San Francisco, California 94104 ("Sumitomo").

WHEREAS, PEBBLE BEACH COMPANY, a California general partnership ("PBC"), and THE MITSUBISHI TRUST AND BANKING CORPORATION, NEW YORK BRANCH, a Japanese banking corporation, as agent and representative for certain banks and financial institutions (collectively, "Mitsubishi") previously entered into that certain PBC Security Agreement dated as of September 5, 1990 (as amended, the "Security Agreement"), pursuant to which PBC granted to Mitsubishi a security interest in (i) certain registered trademarks and service marks, and applications for registration of trademarks and service marks, listed on Schedule A to the Security Agreement, and (ii) certain other registered trademarks and service marks, applications for registration of trademarks and service marks, and licenses of registered trademarks and service marks of PBC, together with the goodwill of the business symbolized thereby (collectively, the "Trademarks").

WHEREAS, a notice of Mitsubishi's security interest in the Trademarks was heretofore given pursuant to that certain Notice of Security Interest in Trademarks dated as of September 4, 1990 executed by PBC and recorded in the records of the Commissioner of Patents and Trademarks on September 18, 1990 at Reel 0740, Frames 443-449.

WHEREAS, as referenced in that certain Notice of Assignment of Security Interest in Trademarks dated April 6, 1993, and recorded in the records of the Commissioner of Patents and Trademarks on December 20, 1993 at Reel 1084, Frames 193-203, Mitsubishi assigned to Sumitomo, all of Mitsubishi's right, title and interest in and to the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Sumitomo hereby terminates the Security Agreement, releases all rights in and to the Trademarks, and reconveys and assigns to PBC all right, title and interest in and to the Trademarks, including, without limitation, those referenced on Schedule A attached hereto. This Release shall constitute notice to all interested parties of the terms hereof.
