D.T.L. Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

**FIRST:** That pursuant to a Unanimous Written Consent of the Board of Directors of the Corporation, a resolution was duly adopted setting forth a proposed amendment to the Certificate of Incorporation of said Corporation, declaring said amendment to be advisable. The resolution setting forth the proposed amendments is as follows:

**RESOLVED:** That, subject to the approval of the sole stockholder of the Corporation, Article **FIRST** of the Certificate of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

**"FIRST:** The name of this corporation is Mercado Software, Inc."

**SECOND:** That in lieu of a meeting and vote of the sole stockholder of the Corporation, the sole stockholder has given written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

**THIRD:** That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

**FOURTH:** That the capital of said Corporation shall not be reduced under or by reason of said amendment.
