TRADEMARK ASSIGNMENT

This Trademark Assignment is by and between Tyco International (US) Inc., having a place of business at 15 Hampshire Street, Mansfield, Massachusetts 02048 (hereinafter referred to as "TYCO"), and Eleanor Bozzacco, having a place of business at 213 Baldwin Terrace, Orange, New Jersey 07050 (hereinafter referred to as "BOZZACCO"). TYCO and BOZZACCO may at times be referred to hereafter individually as a Party or collectively as the Parties.

WHEREAS, BOZZACCO has adopted, used and is using the trademark NITE-LIFE which is registered in the United States Patent and Trademark Office under Registration No. 1,252,949, dated October 4, 1983;

WHEREAS, TYCO is desirous of acquiring said trademark and the registration therefor;

WHEREAS, BOZZACCO wishes to assign the trademark NITE-LIFE and Registration No. 1,252,949 to TYCO, and TYCO wishes to accept the assignment of said mark and registration;

NOW, THEREFORE, in consideration of one thousand dollars (\$1000.00) paid to BOZZACCO by TYCO and for other good and valuable consideration, the receipt of which is hereby acknowledged, BOZZACCO hereby assigns and transfers to TYCO all right, title and interest in and to the NITE-LIFE trademark and Registration No. 1,252,949, together with the goodwill of the business symbolized by the mark, including the right to seek and obtain for TYCO's own benefit injunctive relief and recovery of damages for any past and/or future infringements, including enhanced damages and/or attorneys' fees for willful infringement.

BOZZACCO covenants that she solely owns the NITE-LIFE trademark and registration therefor free and clear of any lien or other encumbrance or restriction, and that there is no claim or demand of any person, or any proceeding pending or, to the best of BOZZACCO's knowledge, threatened, which challenges the sole ownership of BOZZACCO in the NITE-LIFE trademark and registration.

BOZZACCO further covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Trademark Assignment.

BOZZACCO further covenants that she will, upon TYCO's request, promptly execute and deliver to TYCO or its legal representative any and all papers or instruments required to maintain and enforce the NITE-LIFE trademark and registration which may be necessary or desirable to carry out the purposes hereof.
