

and any registrations issuing therefrom, together with the goodwill of the business symbolized by and associated with the Marks.

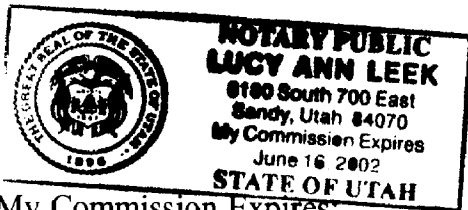
