RELEASE OF TRADEMARK ASSIGNMENT


WHEREAS, Congress, at the request of IFC, has agreed to release and reassign to IFC its interest in the Trademarks listed on Exhibit A hereto;

1. releases and reassigns to IFC, without representation or warranty, express or implied and without recourse, any and all liens, security interests, right, title and interest of Congress pursuant to the Agreement in and to the Trademarks which are described more fully on Exhibit A and the goodwill of the business symbolized by each such Trademark, including any and all proceeds relating thereto; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.


