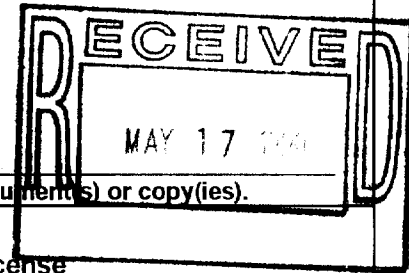

ARTICLE I

The name of the corporation is DC Shoes, Inc.

3. The foregoing amendment of Articles of Incorporation has been duly approved by Unanimous Written Consent of the directors and shareholders of the Corporation dated as of November 17, 1998;

4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of the shareholders in accordance with California Corporations Code section 902.
