To the Secretary of State

Pursuant to the provisions of the Georgia Business Corporation Code, the corporation hereinafter named (the "Corporation") does hereby adopt the following Articles of Amendment:

1. The name of the Corporation is Healthdyne Technologies, Inc.
2. Article 1 of the Articles of Incorporation of the Corporation is hereby amended so as to read as follows:
"The name of the Corporation is Respiroics Georgia, Inc."
3. The amendment herein provided for was duly adopted by the Board of Directors of the Corporation on March 31, 1998 in accordance with the provisions of Section 14-2-1002 of the Georgia Business Corporation Code.
4. The amendment was adopted by the Board of Directors without shareholder action. Shareholder action was not required.
