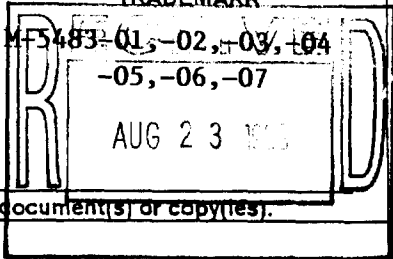

of Directors of the Corporation

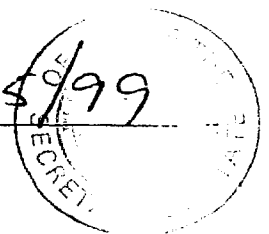
4. The foregoing amendment of Articles of Incorporation has been duly approved by the


