THIS ASSIGNMENT is made effective the 7<sup>th</sup> day of February, 1997.

WHEREAS, Value City Department Stores, Inc., a corporation organized and existing under the laws of the State of Ohio, having a place of business at 3241 Westerville Road, Columbus, Ohio 43224 (hereinafter referred to as the "ASSIGNOR"), has adopted and is using in the United States the mark "MAZZONI" (hereinafter the "Mark"), said Mark being the subject of U.S. Application Serial No. 75/414,191, now U.S. Trademark Registration 2,263,818, filed and owned by ASSIGNOR;

WHEREAS, Value City of Michigan, Inc., a corporation organized and existing under the laws of the State of Michigan, having a place of business at 36901 Warren Road, Westland, Michigan 48185 (hereinafter referred to as the "ASSIGNEE"), desires to acquire said Mark and goodwill associated with said Mark and any and all pending applications therefor and registrations thereof;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the said ASSIGNOR does hereby assign and transfer to the said ASSIGNEE the entire right, title, and interest in and to said Mark, together with the goodwill of the business symbolized by the Mark and the registrations thereof and pending applications therefor, including Registration No. 2,263,818 and all other rights which ASSIGNOR has enjoyed thereunder in the United States, including any and all rights of recovery based on past infringement of said Mark and/or registrations, the same to be held and enjoyed by the ASSIGNEE, its successors and assigns, to the full end of the term for which the aforesaid Mark is registered and any renewals of the term thereof;

FOR THE SAME CONSIDERATION, the said ASSIGNOR also hereby covenants and agrees to and with the said ASSIGNEE, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, the said ASSIGNOR is the sole and lawful owner of the entire right, title and interest in and to the aforesaid application and believes it is the sole and lawful owner of the entire right, title and interest to said Mark and said goodwill associated therewith and that the

same are unencumbered and that the said ASSIGNOR has good and full right and lawful authority to sell and convey the same in the manner herein set forth;

AND for the same consideration, the said ASSIGNOR hereby covenants and agrees to and with the said ASSIGNEE, its successors, legal representatives and assigns, that the said ASSIGNOR will, whenever counsel of the said ASSIGNEE, or the counsel of its successors, legal representatives and assigns, shall advise that it is lawful and desirable, sign all papers and documents, deliver necessary documents including original registration certificates, if available, take all lawful oaths, execute separate confirmatory assignments, and do all acts necessary or desirable to be done for the procurement, maintenance, enforcement and defense of said Mark without charge to the said ASSIGNEE, its successors, legal representatives and assigns.
