

### CURTIFICATE OF OWNERSHIP AND MERGER MERGING KSL DESERT RESORTS, INC. INTO

# KSL LANDMARK CORPORATION (PURSUANT TO SECTION 253 OF THE GENERAL CORPORATION LAW OF DELAWARE)

KSL Landmark Corporation, a Delaware corporation (the "Corporation"), does hereby certify:

FIRST: That the Corporation is incorporated pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the capital stock of KSL Desert Resorts, Inc., a Delaware corporation.

THIRD: That the Corporation, by the following resolutions of its Board of Directors, duly adopted on the 14th day of May, 1997, determined to merge into itself KSL Desert Resorts, Inc. effective July 1, 1997, on the conditions set forth in such resolutions:

NOW, THEREFORE, LET IT BE RESOLVED, that the Corporation merge into itself its subsidiary, KSL Desert Resorts, Inc., effective July 1, 1997, and assume all of said subsidiary's liabilities and obligations;

FURTHER RESOLVED, that upon consummation of the merger, that the Corporation's name be changed to KSL DESERT RESORTS, INC. effective July 1, 1997; and

FURTHER RESOLVED, that the Executive Vice President of this Corporation be and he hereby is directed to make, execuse and acknowledge a certificate of ownership and merger on behalf of the Corporation setting forth a copy of the resolutions to merge said KSL Desert Resorts. Inc. effective July 1, 1997 into this Corporation, to assume said subsidiary's liabilities and obligations and change the name of the Corporation to KSL Desert Resorts, Inc., and to file the same in the office of the Secretary of State of the State of Delaware and a certified copy thereof in the Office of the Recorder of Deeds of New Castle.
