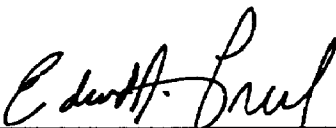

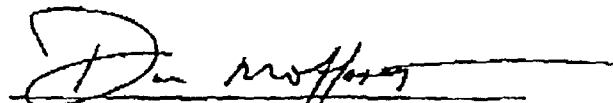
RESOLVED, that upon approval of the stockholders of the Corporation, Article I of the Certificate of Incorporation shall be amended to read as follows:
