**TRADEMARK ASSIGNMENT**

WHEREAS, prior to October 6, 1995, Chemical New Jersey Holdings, Inc. ("CNJH") adopted, used and owned the mark "HORIZON" (the "Mark") in connection with banking services;

WHEREAS, the Mark is registered on the Principal Register of the United States Patent and Trademark Office in connection with banking services, under Registration No. 1,362,420, registered on September 24, 1985;

WHEREAS, as of October 6, 1995, the outstanding capital stock of CNJH was transferred by its parent and sole shareholder, Chemical Banking Corporation ("Assignee"), a Delaware corporation with its principal place of business located at 270 Park Avenue, New York, New York 10017, to PNC Bank Corp. ("PNC") a Pennsylvania corporation with its principal place of business located at One PNC Plaza, Pittsburgh, Pennsylvania 15222, pursuant to a Stock Purchase Agreement between Assignee and PNC dated March 7, 1995 (the "Stock Purchase Agreement"), under which Assignee retained all rights to own and use the Mark in connection with banking services;

WHEREAS, pursuant to the Stock Purchase Agreement, as of October 6, 1995, PNC caused CNJH to be merged into its wholly owned subsidiary, PNC Bancorp, Inc., a Delaware corporation, with its principal place of business located at Marine Bank Building, 9<sup>th</sup> & State Streets, Erie, Pennsylvania 16501 ("Assignor");


WHEREAS, since October 6, 1995, consistent with the Stock Purchase Agreement, Assignee has continued to use the Mark in connection with banking services;

WHEREAS, on March 31, 1996, Assignee changed its name to The Chase Manhattan Corporation, in connection with the merger into Assignee of the entity then known by that name; and

WHEREAS, Assignee, PNC and Assignor desire to confirm Assignee's ownership of the Mark and the above-referenced registration as contemplated in the Stock Purchase Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, together with the registration thereof, effective, nunc pro tunc, as of October 6, 1995.
