

TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of December 18, 1998, is by Melaleuca, Inc., an Idaho corporation (the "Grantor"), in favor of Bank of America National Trust and Savings Association in its capacity as collateral agent for the Benefited Parties (as defined in the Intercreditor Agreement referred to below) (the "Collateral Agent").

W I T N E S S E T H :

WHEREAS, the Grantor has entered into a Credit Agreement, dated as of December 18, 1998 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), with the several financial institutions from time to time party thereto (the "Lenders") and Bank of America National Trust and Savings Association, as agent, pursuant to which such financial institutions have agreed to make available to the Grantor term loans and a revolving credit facility;

WHEREAS, pursuant to certain Note Agreements (as defined in the Intercreditor Agreement referred to below) the Grantor has issued to various financial institutions certain Senior Notes (as defined in the Intercreditor Agreement);

WHEREAS, certain creditors of the Grantor have entered into an Intercreditor Agreement dated as of the date hereof (as amended, supplemented or otherwise modified from time to time, the "Intercreditor Agreement") pursuant to which the Grantor, the Agent, the holders of the Senior Notes and the Collateral Agent have agreed that the Credit Obligations (as defined in the Intercreditor Agreement), the Senior Note Obligations (as defined in the Intercreditor Agreement) and the Hedging Obligations (as defined in the Intercreditor Agreement) shall be secured *pari passu*;

WHEREAS, the Grantor has also executed a Security Agreement, dated as of December __, 1998 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), with the Collateral Agent;

WHEREAS, the obligations of the Grantor in respect of the Benefited Obligations are to be secured pursuant to this Agreement; and

WHEREAS, the Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantor agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided in the Security Agreement.

SECTION 2. Grant of Security Interest. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby assigns to the Collateral Agent for the benefit of the Benefited Parties, and grants to the Collateral Agent for the benefit of the Benefited Parties, a continuing security interest in the Grantor's right, title and interest in and to the following, whether now or hereafter existing or acquired (the "Trademark Collateral"): all trademarks, service marks, business names, designs, logos, indicia and other source and/or business identifiers, and the goodwill of the business relating thereto and all registrations and applications for registrations which have heretofore been or may hereafter be issued or filed thereon throughout the world (including without limitation those listed on Schedule I hereto), all renewals of any of the foregoing, and all proceeds of, and rights associated with, the foregoing (including license royalties and proceeds of infringement suits), the right to sue for all past, present or future infringements of any of the foregoing and all rights corresponding thereto throughout the world in and to all of the foregoing.


SECTION 3. Security Agreement. This Agreement has been executed and delivered by the Grantor for the purpose of recording the security interest of the Collateral Agent on behalf of each Benefited Party in the Trademark Collateral with the United States Patent and Trademark Office and corresponding offices in other countries of the world. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to the Collateral Agent under the Security Agreement. The Security Agreement (and all rights and remedies of the Collateral Agent thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Release of Security Interest. Upon payment in full of all Benefited Obligations and the termination of all commitments of the Lenders under the Credit Agreement, the Collateral Agent shall, at the Grantor's expense, execute and deliver to the Grantor all instruments and other documents as may be necessary or proper to release all liens on and security interests in the Trademark Collateral which have been granted hereunder.

SECTION 5. Acknowledgment. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

IN WITNESS WHEREOF, the undersigned has caused this Agreement to be duly executed and delivered by its officer thereunto duly authorized as of the day and year first above written.
