TRADEMARK AND COPYRIGHT ASSIGNMENT

THIS ASSIGNMENT OF REGISTERED TRADEMARKS AND COPYRIGHTS is made this 17th day of December, 1997, by and between Press-Telegram Publications, Inc., a California corporation ("KRI Subsidiary"), and NJN Publishing Company, a Delaware corporation ("Buyer").

WHEREAS, pursuant to an Asset Purchase Agreement, dated as of November 4, 1997 (the "Agreement"), by and among Knight-Ridder, Inc., a Florida corporation, KRI Subsidiary, P.T. Sales and Marketing, Inc., a California corporation, and Garden State Newspapers, Inc., a Delaware corporation ("Garden State") (as such Agreement has been assigned by Garden State to Buyer), KRI Subsidiary has agreed to assign to Buyer, and Buyer has agreed to accept from KRI Subsidiary for the consideration and upon the terms and conditions set forth in the Agreement the Trademarks and Copyrights. All capitalized terms used herein without definition shall have the meanings ascribed to them in the Agreement.

WHEREAS, KRI Subsidiary is the sole and exclusive owner of the right, title and interest in and to the Trademarks and the good will appurtenant thereto which Trademarks are listed and described in ANNEX "A" attached hereto;

WHEREAS, KRI Subsidiary is the sole and exclusive owner of the right, title and interest in and to the Copyrights which Copyrights are listed and described in ANNEX "B" attached hereto;

WHEREAS, Buyer desires to acquire the entire right, title and interest in and to the Trademarks and the goodwill appurtenant thereto; and

WHEREAS, Buyer desires to acquire the entire right, title and interest in and to the Copyrights;

NOW THEREFORE, for good and valuable consideration paid by Buyer to KRI Subsidiary, the receipt and sufficiency of which are hereby acknowledged, KRI Subsidiary does hereby assign and transfer unto Buyer (i) all of its right, title and interest in and to the Trademarks, together with the good will appurtenant thereto and (ii) all of its right, title and interest in and to the Copyrights, together with the right to secure all renewals and extensions of the Copyrights, pursuant to the laws now or hereafter pertaining thereto, and all existing causes of action, if any, for past infringement of the Copyrights.
