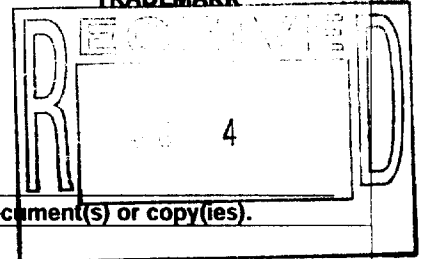

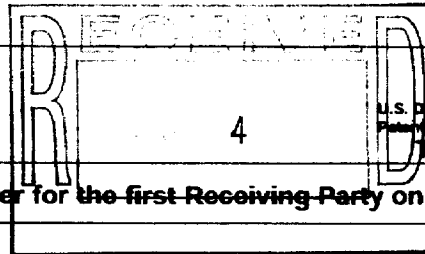


WHEREAS, the Assignor has intended to use the Marks listed on the Attached Schedule in commerce


