

**CERTIFICATE OF AMENDMENT TO
CERTIFICATE OF INCORPORATION OF**

NEY DENTAL, INC.

Ney Dental, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify:

FIRST: That the Board of Directors of the Corporation, by unanimous written consent dated April 15, 1999, adopted resolutions proposing and declaring advisable the following Amendment to the Certificate of Incorporation of the Corporation:

RESOLVED, that the following Amendment to the Corporation's Certificate of Incorporation be submitted to the Shareholder of the Corporation with the recommendation of the Directors that the same be approved and adopted by said Shareholder:

Article **FIRST** is amended to read as follows:

FIRST. The name of this corporation shall be:

Degussa-Ney Dental, Inc.

RESOLVED, that the proper officers of this Corporation, if the sole shareholder approves as required by law such name change, be and they hereby are authorized and directed to file a Certificate of Amendment to the Certificate of Incorporation with the Secretary of State of Delaware and to cause a copy thereof certified by such Secretary of State to be recorded with the Recorder of New Castle County, Delaware, and also to file the necessary documents, if any, concerning this Amendment with the appropriate filing officers in all jurisdictions where the Corporation has heretofore qualified to do business as a foreign corporation.

SECOND: That in lieu of a meeting and vote of stockholders, the sole stockholder has given written consent to such Amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

THIRD: That the aforesaid Amendment was duly adopted in accordance with the applicable provisions of Section 228 and 242 of the General Corporation Law of the State of Delaware.
