

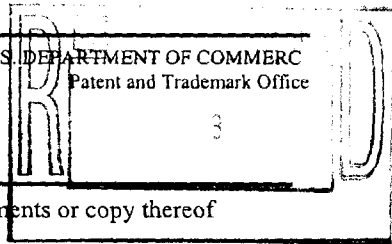

TRADEMARK ASSIGNMENT

WHEREAS, FSI International, Inc., a Minnesota corporation having a place of business at 322 Lake Hazeltine Drive, Chaska, Minnesota 55318 (Assignor), has filed an intent-to-use trademark application in the United States Patent and Trademark Office for DyconESM as set forth on the attached Schedule A (hereinafter referred to as the "Trademark");

Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may reasonably require in order to vest all of Assignor's rights, title and interest in and to the Trademark in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession and control of Assignor.

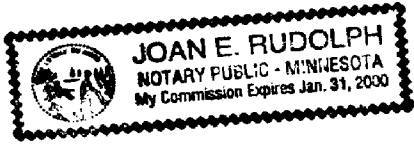
