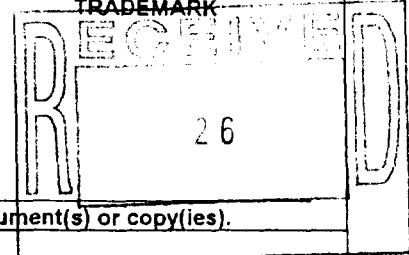



# TRADEMARK ASSIGNMENT

This **TRADEMARK ASSIGNMENT** (the "**Agreement**") is made as of December 19, 1997, by and among National Spirit Group, Ltd., a Texas limited partnership ("**Seller**"), and NSG Corporation, a Delaware corporation ("**Purchaser**").

## RECITALS:

A. Seller and Purchaser have entered into an Asset Purchase and Sale Agreement dated as of November 26, 1997, as amended (as amended, the "**Asset Purchase Agreement**").

B. Pursuant to the Asset Purchase Agreement, Seller has agreed to sell to Purchaser the Property (as defined in the Asset Purchase Agreement), which include all trademarks of the Seller, including without limitation those contained on attached Exhibit A (the "**Trademarks**").

## AGREEMENT:

In consideration of the premises and of the agreements contained herein and in the Asset Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, and pursuant to the terms of the Asset Purchase Agreement, the parties hereto agree as follows:

1. **Assignment.** Seller, for itself and its successors and assigns forever, hereby assigns, transfers and conveys to Purchaser all of its right, title and interest in and to the Trademarks, in the United States and elsewhere, including the right to sue for past infringement, together with the goodwill of the business symbolized by the Trademarks and all registrations and pending applications for the Trademarks. Upon the execution of this Agreement, Seller shall cease all use of the Trademarks and shall not use any marks similar to any of the Trademarks.

2. **Additional Rights and Obligations.** Seller and Purchaser hereby agree and acknowledge that this Agreement is being entered into pursuant to and subject to the terms and conditions set forth in the Asset Purchase Agreement and that additional rights and obligations of the parties are expressly provided for therein, and that the execution and delivery of this Agreement shall not impair or diminish any of the rights or obligations of any of the parties to the Asset Purchase Agreement as set forth therein.

3. **Reasonable Efforts; Cooperation.** The parties shall use their reasonable efforts to take, or cause to be taken, all actions and to do, or cause to be done, all things reasonably necessary, proper or advisable to consummate and make effective as promptly as practicable the provisions contained herein and to cooperate

with each other in connection with the foregoing.

4. **Further Assurances.** The parties agree to take such further actions and execute and deliver such other documents, certificates, agreements and other instruments as may be necessary or desirable in order to consummate or implement this Agreement.


5. **Binding Effect.** This Agreement, and all the terms and provisions hereof, shall be binding upon and shall inure to the benefit of Seller and Purchaser, and their respective successors and permitted assigns.
