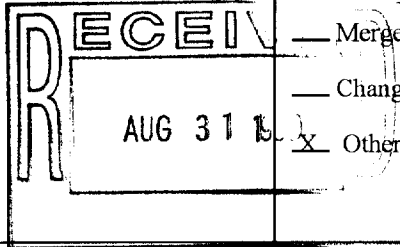

## **RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

This Release of Security Interests in Trademarks is granted and conveyed as of July 23, 1999 by Transamerica Business Credit Corporation, a Delaware corporation, having its principal office at 9399 West Higgins Road, Suite 600, Rosemont, Illinois 60018 ("Lender"), in favor of Bruce Molloy ("Molloy") and Molloy Group, Inc., a Delaware corporation, having its principal office at Four Century Drive, Parsippany, New Jersey 07054.

WHEREAS, Lender and Molloy entered into a Trademark Security Agreement (the "Security Agreement") on February 20, 1998, under which Molloy granted, assigned and conveyed to Lender a security interest in Molloy's entire right, title and interest in and to the Collateral (as defined in the Security Agreement), including, without limitation, the registered trademarks listed on Schedule A hereto;

WHEREAS, the United States Patent and Trademark Office recorded the Security Agreement on May 8, 1998, against the Collateral at Trademark Reel 1723, Frame 0989;

WHEREAS, Molloy sold, assigned, and transferred to Molloy Group, Inc., its lawful successors and assigns, his entire right, title and interest in and to the Collateral pursuant to that certain Assignment Agreement by and between Molloy and Molloy Group, Inc., dated as of July 23, 1999; and

WHEREAS, Molloy and Molloy Group, Inc. have satisfied all outstanding obligations under the Security Agreement, and the parties seek to make a record of Lender's release and reassignment to Molloy Group, Inc. of any and all of its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Lender hereby (1) releases, discharges and relinquishes its security interest in the Collateral, and (2) reassigns to Molloy Group, Inc. all right, title, and interest that Lender may have had in the Collateral, the goodwill associated with the Collateral, any and all applications or registrations for the Collateral, and the right to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits. Lender specifically acknowledges that the Security Agreement is no longer effective, that Lender does not own any rights to or have any ownership interest in the Collateral, and that all of its rights and remedies with respect to the Collateral have been and are hereby extinguished.
