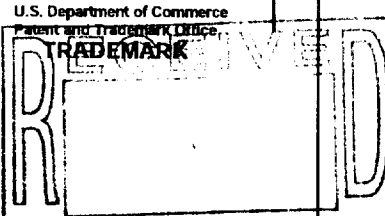




PARTIAL RELEASE OF SECURITY
INTEREST IN TRADEMARK

KNOW ALL MEN BY THESE PRESENTS, that CONGRESS FINANCIAL CORPORATION, a Delaware corporation (hereinafter referred to as "Secured Party"), having an office at 1133 Avenue of the Americas, New York, New York 10036, DOES HEREBY CERTIFY that the security interest it holds in that certain trademark of BRAWN OF CALIFORNIA, INC., a California corporation ("Brawn") entitled "FREIGHTER", bearing Registration Number 1,365,700 (the "Freighter Trademark") pursuant to a certain Trademark Collateral Assignment and Security Agreement, dated November 14, 1995, by and among BRAWN, GUMP'S CORP., a California Corporation, HANOVER HOLDING CORP., a Delaware corporation, successor by merger of The Company Store, Inc. with and into Tweeds, Inc., which has changed its name to Hanover Holding Corp., (each individually a "Debtor" and collectively, "Debtors") and Secured Party, recorded in the United States Patent and Trademark Office on December 14, 1995, at Reel 1431, Frame 0878, as amended by First Amendment to Trademark Collateral Assignment and Security Agreement, dated as of September 30, 1998 (the "Trademark Security Agreement"), together with the goodwill of the business symbolized by the Freighter Trademark, is released and all interests in the Freighter Trademark previously assigned to Secured Party under the Trademark Security Agreement are hereby reassigned to Brawn, without representation or warranty of any kind, nature or description;

PROVIDED, THAT, nothing herein shall (a) constitute a release or reassignment of the security interests in any other trademarks or other property, other than the Freighter Trademark, and the goodwill of the business symbolized thereby, assigned by way of security by Debtors pursuant to the Trademark Security Agreement; or (b) impair or affect Secured Party's security interests in any existing inventory, packaging, labels or other personal property of Brawn or its affiliates to which the Freighter Trademark is affixed or on which the Freighter Trademark otherwise appear.

IN WITNESS WHEREOF, Secured Party has caused this Partial Release of Security Interest in Trademark to be executed by its duly authorized corporate officer this 17 day of August 1999.
