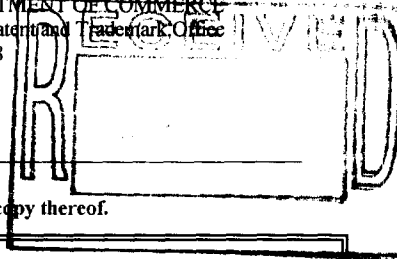




TRADEMARK ASSIGNMENT
