**RELEASE OF SECURITY INTEREST IN UNITED STATES
TRADEMARKS AND PATENTS**

THIS RELEASE is granted by **Bankers Trust Company, as Collateral Agent** (hereinafter referred to as the "Collateral Agent"), to **Labtec Corporation (f/k/a Labtec Inc. and also f/k/a Labtec Enterprises, Inc.)**, a Delaware corporation (hereinafter referred to as the "Assignor").

WHEREAS, Assignor and Collateral Agent entered into a Security Agreement (hereinafter referred to as the "Security Agreement") and related Assignment of Security Interest in United States Trademark and Patents (hereinafter referred to as the "Security Interest Agreement") by which Collateral Agent acquired security interests in (i) all of the Assignor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all of the Assignor's rights, title and interest in and to any United States patents and, pending patent applications (the "Patents") together with (iii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks and Patents, (iv) the goodwill of the businesses with which the Marks are associated and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same including but not limited to the U.S. trademark registrations listed on Schedule A hereto to secure the satisfactory performance and payment of all of Assignor's Obligations as defined in the Security Agreement;

WHEREAS, the Security Agreement was recorded in the U.S. Patent and Trademark Office on October 30, 1997 at Trademark Reel 1648 at Frames 0600-0605; and


WHEREAS, all of the Assignor's Obligations under the Security Agreement have been satisfied and the Collateral Agent desires to release the security interests granted in the Security Agreement and the Security Interest Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby releases the security interests granted in the Security Agreement and Security Interest Agreement in (i) all of the Assignor's right, title and interest in and to the Marks set forth on Schedule A, (ii) all of the Assignor's rights, title and interest in the Patents, in each case together with (iii) all Proceeds and products of the Marks and Patents, (iv) the goodwill of the businesses with which the Marks are associated and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same

The Collateral Agent expressly agrees to execute and deliver, at the request of the Assignor, all papers, instruments, and other documents and to perform any other acts the Assignor reasonably may require in order to terminate the security interests granted in the Security Agreement and the Security Interest Agreement and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignor.


