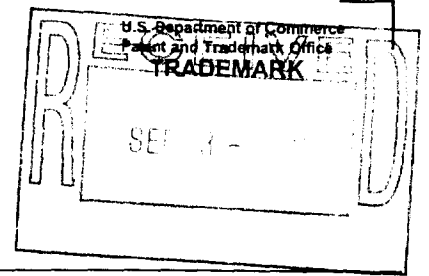



ASSIGNMENT

WHEREAS, BRITISH TELECOMMUNICATIONS public limited company, a company organised under the laws of England (registered number 1800000), having its principal offices at 81 Newgate Street, London EC1A 7AJ, U.K. (the "Assignor"), is the owner of the following trademark for which an application in the United States Patent and Trademark Office is pending:

WHEREAS, IQ PORT LIMITED, a private limited liability company of the U.K. (registered number 3462666) having its principal offices at 15-18 Featherstone Street, London EC1Y 8QS, U.K. (the "Assignee"), is the successor of the business of the Assignor to which said Trade mark pertains, and is desirous of acquiring said Trademark and the application therefore.

NOW, THEREFORE, in consideration of the payment of £2,000 plus VAT, if any, the Assignor hereby assigns to the Assignee all right, title and interest in the United States in and to said Trademark and said application therefor, together with the goodwill of the business symbolized by said Trademark and said application to register said Trademark. The Assignor hereby represents that said right, title and interest in the Trademark are transferred free of all charges, options, licenses and encumbrances.

The Assignor hereby covenants with the Assignee that, without express authorization given hereafter in writing by the Assignee or its successors in title to the Assignor, the Assignor will not apply to register the Trademark anywhere in the world, for a period three (3) years, dating from June 3, 1998, unless the Assignee, and its related companies, cease to use the Trademark.

The Assignor agrees, at the request of the Assignee, to transfer to the Assignee the Assignor's files and records (including those in the possession of its agents) relating to the filing, prosecution and maintenance of the Trademark.

The Assignor warrants that it is the applicant for the Trademark, and the application therefore has not lapsed.

The Assignor agrees, at the request of the Assignee, to execute any further documents and do all things which may be necessary to enable the Assignee to record this assignment in the records of the United States Patent and Trademark Office.

The transaction effected by this assignment does not form part of a larger transaction or series of transactions in respect of which the amount or value, or aggregate amount or value, of the consideration exceeds £60,000.

This assignment is governed by and shall be construed in accordance with English law and the parties submit to the jurisdiction of the English courts for all purposes relating to this assignment, except insofar as it shall be necessary for the parties to submit to the law of the United States or the jurisdiction of a court of competent jurisdiction of the United States for the purpose of determining the right to sue and register the Trademark in the United States.

This assignment may be signed in counterparts.

Killworth, Gottman, Hagan & Schaeff, L.L.P., whose postal address is One Dayton Centre, One South Main Street, Suite 500, Dayton, Ohio 45402-2023, is hereby designated the Assignee's representative upon whom notice or process in proceedings affecting the Trademark and application may be served.

The Commissioner of Patents and Trademarks is requested to issue the Certificate of Registration to the Assignee, IQ PORT LIMITED.
