PATENT/TRADEMARK/TRADE NAME LIEN

THIS LIEN, effective as of the 2nd day of September, 1999, from **The Miller Company**, a corporation organized and existing under the laws of the State of Connecticut and having its principal place of business at 290 Pratt Street, Meriden, Connecticut, (hereinafter referred to as "Debtor") and **State Street Bank and Trust Company**, a Massachusetts trust company having a place of business at 225 Asylum Street, Hartford, Connecticut (hereinafter referred to as "Secured Party"),

WITNESSETH:

WHEREAS, Debtor is the owner of the patents, trademarks and/or tradenames set forth on Exhibit A hereto, and the good will of the business appurtenant thereto, together with all registrations and applications for registration thereof and any and all reissues, continuations and continuations-in-part with respect thereto, all as more particularly set forth on Exhibit A (collectively, the "Patent/Trademark Collateral");
