**ASSIGNMENT OF TRADEMARK RIGHTS
AND REDEMPTION OF OPTION**

This Agreement is made as of July 30, 1999 between the Estate of John Gross, having its address at 1521 "M" South Edgewood Street, Baltimore, Maryland 21227 ("Gross") and Star Industries, Inc., a New York corporation having its address at 345 Underhill Boulevard, Syosset, New York ("Star").

Gross desires to sell to Star certain trademark rights and also to terminate a certain option right held by Gross in exchange for the total amount of \$40,000.

NOW, THEREFORE, the parties agree as follows:

1. Introduction

Gross is the owner of the trademark DUNCAN'S for use on scotch whiskey together with U.S. trademark registration no. 2,073,658 therefor, a copy of which is annexed hereto as Exhibit A. Gross also holds an option to purchase the trademark BLANSAC for use on brandy together with the goodwill of the business relating thereto, which trademark is not currently registered with the U.S. Trademark Office.

2. Assignment of Trademark

For \$ [REDACTED] cash, Gross, for itself and its predecessors in title, hereby assigns to Star all right, title and interest in and to the trademark DUNCAN'S and the US registration for that trademark, together with the goodwill and business relating thereto.

3. Option Redemption

For \$ [REDACTED] cash, Gross agrees that its option to purchase all of the right, title and interest in the BLANSAC mark is hereby terminated. The terms of the option are set forth in the August 31, 1966 agreement between the parties attached hereto as Exhibit B.


