

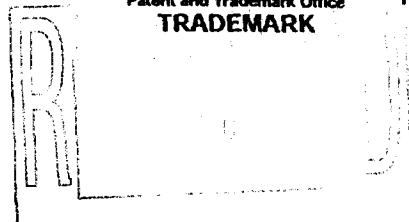

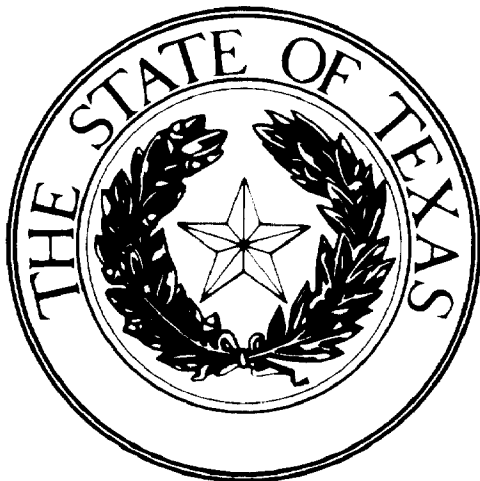

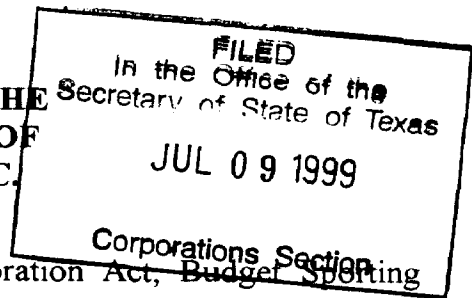

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
BUDGET SPORTING GOODS, INC.**



Pursuant to the provisions of the Texas Business Corporation Act, Budget Sporting Goods, Inc. (the "Corporation") hereby adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Budget Sporting Goods, Inc.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the sole shareholder of the corporation on July 7, 1999 in conformity with the provisions of the Texas Business Corporation Act:

Article One is hereby amended to read in its entirety as follows:

ARTICLE ONE

The name of the corporation is Softball Sales, Inc.

ARTICLE THREE

The number of shares of the capital stock of the corporation issued and outstanding at the time of adoption was 72,364 shares of common stock, without par value, all of which were entitled to vote thereon.

ARTICLE FOUR

The holder of all of the shares outstanding and entitled to vote on said amendment has signed a written consent pursuant to Article 9.10 of the Texas Business Corporation Act adopting said amendment. No written notice is required by such Article 9.10. No shares were entitled to vote as a class or series.


ARTICLE FIVE
