

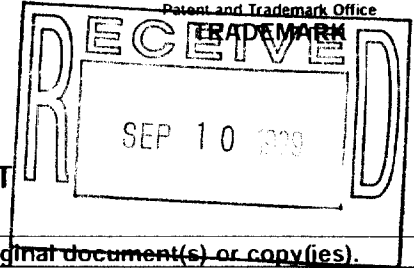

TRADEMARK ASSIGNMENT

Assignor further covenants that it will, upon request, execute, deliver to Assignee further documents and instruments, and take all other lawful acts deemed necessary by Assignee, to enable Assignee to obtain, maintain and enforce the full benefit of the successors, assigns or other legal representatives of Assignee.

This Assignment shall be binding upon the successors, assigns or other legal representatives of Assignor and shall inure to the benefit of the successors, assigns or other legal representatives of Assignee.
