

OF

### TARGET MARKETING INTERNATIONAL, INC.

1.

The name of the corporation is Target Marketing International, Inc.

2.

The Articles of Incorporation are amended by striking Article I in its entirety and inserting in lieu thereof the following Article I:

"T

The name of the corporation is OnTarget, Inc."

3.

The Articles of Incorporation are amended by striking Article II in its entirety and inserting in lieu thereof the following Article II:

"II.

The Corporation shall have authority to issue not more than 100,000,000 shares, \$.01 par value per share, all of which shall be of the same class and designated the "Common Stock." The Common Stock shall together have unlimited voting rights and be entitled to receive the net assets of the Corporation upon dissolution."
