ASSIGNMENT OF INTEREST IN TRADEMARK ASSIGNMENT

WHEREAS, Deer Stags, Inc., a New York corporation ("Debtor"), with its principal place of business at 1414 Avenue of the Americas, New York, New York 10019 entered into a Trademark Collateral Assignment and Security Agreement (the "Trademark Agreement") dated March 4, 1998 with Congress Talcott Corporation ("Talcott"), having an office at 1133 Avenue of the Americas, New York, New York 10036 to secure payment of obligations of Debtor to Talcott; and

WHEREAS, an executed copy of the Trademark Agreement was filed at the United States Patent and Trademark Office in Reel 1713, Frame 0614 on March 9, 1998; and

WHEREAS, Talcott has been merged into Congress Financial Corporation ("Congress") and that effective on the close of business on April 1, 1999 Congress will be transferring certain assets to The CIT Group/Commercial Services, Inc. ("CIT"), including all of Congress' right, title and interest in the Trademark Agreement;

WHEREAS, CIT has requested that Congress assign its interest in the trademarks listed on Exhibit A annexed hereto as part of the transfer of assets;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Congress hereby:

1. assigns to CIT any and all liens, security interests, right, title and interest of Congress pursuant to the Trademark Agreement including, without limitation, its interest in the trademarks which are described more fully on Exhibit A, without recourse or representation or warranty, express or implied; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the assignment hereby given.

IN WITNESS WHEREOF, Congress has caused this Assignment to be signed by its duly authorized officer as of this 31 day of March, 1999.


