

ASSIGNMENT

WHEREAS, KENLIN PET SUPPLY, INC., a Delaware corporation having offices at 301 Island Road, Mahwah, New Jersey 07430 (hereinafter referred to as "ASSIGNOR") is the current owner of the entire right, title and interest in and to United States Service Mark Registration No. 1,820,264, issued February 8, 1994, for the mark THE GOOD NEIGHBOR PET PROFESSIONALS for retail pet supply stores;

WHEREAS, CENTRAL GARDEN & PET COMPANY, a Delaware corporation, having offices at 3697 Mt. Diablo Boulevard, Lafayette, California 94549 (hereinafter referred to as "ASSIGNEE") is desirous of acquiring ASSIGNOR's entire right, title and interest in and to United States Service Mark Registration No. 1,820,264 and the mark THE GOOD NEIGHBOR PET PROFESSIONALS and its appurtenant goodwill;

supply stores, the goodwill of the business appurtenant to and connected with said mark, all rights at common law in said mark, and ASSIGNOR further assigns, transfers, sells and conveys to ASSIGNEE, its successors, legal representatives and assigns, the right to renew, protect, defend and enforce any and all rights to said mark including the right to sue for past infringement, the right to enforce any and all trademark rights of ASSIGNOR and causes of action therefor, presently known or unknown and inuring to ASSIGNEE, and the right to recover all claims for damages or for compensation for past infringement arising out of any cause of action, whether presently known, unknown, accrued or to accrue.

ASSIGNOR agrees to cooperate fully with ASSIGNEE (at no cost to ASSIGNOR) in connection with perfecting the transfer of all rights to and the vesting of full and complete title in ASSIGNEE, including, without limitation by enumeration, agreeing to the recordation of this Assignment on the records of the United States Patent and Trademark Office. ASSIGNOR agrees further to cooperate fully with ASSIGNEE (at no cost to ASSIGNOR) in connection with enforcing and defending the rights transferred and particularly in connection with executing any and all instruments deemed by ASSIGNEE to be necessary or desirable to implement and accomplish the transfer, enforcement and/or defense of rights granted by ASSIGNOR hereunder.
