

TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

THIS TRADEMARK AND COPYRIGHT SECURITY AGREEMENT, dated as of August 31, 1999 (this "Agreement"), is from JMYZ, INC., a Florida corporation (the "Grantor"), in favor of SUNTRUST BANK, MIAMI, N.A., a national banking association (the "Grantee").

WITNESSETH:

WHEREAS, pursuant to the provisions of that certain Variable Rate Promissory Note, dated as of the date hereof (the "Note"), made by the Grantor payable to the order of the Grantee in the original principal amount of \$800,000.00, the Grantee has agreed to make a loan to the Grantor in like principal amount; and

WHEREAS, the Grantee is willing to make the loan evidenced by the Note, but only upon the condition, among others, that the Grantor shall have executed and delivered to the Grantee, that certain Commercial Security Agreement, dated as of the date hereof (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement") and this Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby agrees as follows:

1. **DEFINED TERMS.** In addition to terms defined elsewhere in this Agreement, the following terms shall have the following meanings:

"**Copyright License**" shall mean any and all rights now owned or hereafter acquired by the Borrower under any written agreement granting any right to use any Copyright or Copyright registration.

"**Copyrights**" shall mean all of the following now owned or hereafter acquired by the Borrower: (a) all copyrights and general intangibles of like nature (whether registered or unregistered), now owned or existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, including all registrations, recordings and applications in the United States Copyright Office or in any similar office or agency of the United States, any state or territory thereof, or any other country or any political subdivision thereof, and (b) all reissues, extensions or renewals thereof.

"**Trademark License**" shall mean rights under any written agreement now owned or hereafter acquired by the Borrower granting any right to use any Trademark.

"**Trademarks**" shall mean all of the following now owned or hereafter acquired by the Borrower: (a) all trademarks, trade names, corporate names, business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature (whether registered or unregistered), now owned or existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state or territory thereof, or any other country or any political subdivision thereof; (b) all reissues, extensions or renewals thereof; and (c) all goodwill associated with or symbolized by any of the foregoing.

2. **GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL AND COPYRIGHT COLLATERAL.** As security for the Obligations (as such term is defined in the Security Agreement), the

Grantor hereby grants to the Grantee a continuing first priority security interest in all of the Grantor's right, title and interest in, to and under the following (collectively, the "Collateral"):

(a) the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

(i) all of its Trademarks and Trademark Licenses to which it is a party including those referred to on Exhibit A hereto;

(ii) all reissues, continuations or extensions of the foregoing;

(iii) all goodwill of the business conducted with the use of, and symbolized by, each Trademark and each Trademark License; and

(iv) all products and proceeds of the foregoing, including, without limitation, all royalties, fees and other payments made on or in respect thereof, and any claim by the Grantor against third parties for past present or future (x) infringement or dilution of any Trademark or Trademarks licensed under any Trademark License, or (y) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License; and

(b) the following, whether presently existing or hereafter created or acquired (collectively, the "Copyright Collateral"):

(i) all of its Copyrights and Copyright Licenses to which it is a party including those referred to on Exhibit A hereto; and

(ii) all reissues, continuations or extensions of the foregoing; and all products and proceeds of the foregoing, including, without limitation, all royalties, fees and other payments made on or in respect thereof, and any claim by the Grantor against third parties for past, present or future infringement or dilution of any Copyright or any Copyright licensed under any Copyright License.

3. **SECURITY AGREEMENT.** The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to the Grantee pursuant to the Security Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Grantee with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
