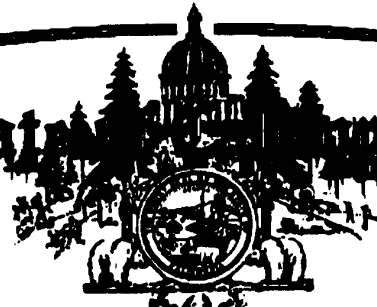

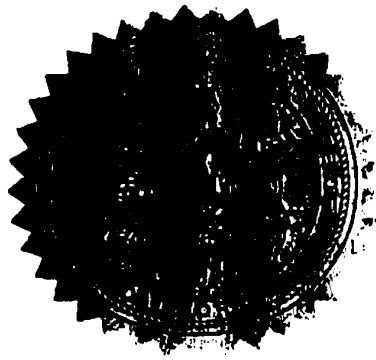

2. The amendment to the Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors of the Company.
3. The amendment to the Amended and Restated Articles of Incorporation has been duly approved by the shareholders of the Company in accordance with Section 902 and 903 of the California Corporations Code. 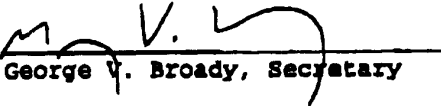
