ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT is made as of May 28, 1999 by and between SEAGATE SOFTWARE, INC., a Delaware corporation, with offices at 915 Disc Drive, Scotts Valley, California 95066 ("Assignor") and VERITAS Software Corporation, a Delaware corporation formerly named VERITAS Holding Corporation, with offices at 1600 Plymouth Street, Mountain View, California 94043 ("Assignee").

WHEREAS, Assignor, Assignee, and certain other parties are parties to that certain Amended and Restated Agreement and Plan of Reorganization, dated April 15, 1999, pursuant to which Assignor has sold a portion of its ongoing and existing business to Assignee (the "transferred business") such that Assignee is Assignor's successor thereto.

WHEREAS, in connection therewith, Assignor desires to assign those trademarks and service marks to Assignee which pertain to the transferred business.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor assigns, sets over, and transfers to Assignee the entire right, title, and interest in and to the trademarks, service marks, and ITU Marks identified in Schedule A, including all common law rights, applications to register, and/or registrations relating thereto, together with the goodwill of the business symbolized by each such trademark and/or service mark.

FURTHER, Assignor covenants and agrees that, to the best of its knowledge and belief, Assignor has the full right to convey the entire interest herein assigned and that it has not executed any agreement in conflict herewith.
