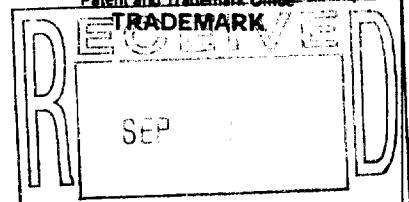

ASSIGNMENT OF PATENTS AND TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, the receipt of which is hereby acknowledged, the undersigned assignor ("Assignor") hereby GRANTS, ASSIGNS and CONVEYS to PEOPLES HERITAGE BANK, a Maine state chartered financial institution, with its principal place of business at One Portland Square, P.O. 
