BILL OF SALE AND ASSIGNMENT

THIS BILL OF SALE AND ASSIGNMENT ("Bill of Sale and Assignment") is made and given this 4th day of January, 1996, by THE WOODLANDS CORPORATION, a Delaware corporation, and THE FORT CROCKETT HOTEL LIMITED, a Texas limited partnership (collectively "Seller"), to FERTITTA HOSPITALITY, INC., a Texas corporation ("Purchaser").

WHEREAS, by Special Warranty Deeds (the "Deeds") delivered contemporaneously with the delivery of this Bill of Sale and Assignment, Seller has conveyed to Purchaser that certain property in Galveston, Galveston County, Texas described in the Deeds and referred to herein as the "Property".

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby GRANTS, SELLS, TRANSFERS, ASSIGNS and DELIVERS to Purchaser free and clear of all encumbrances, except as provided hereinbelow:

- (a) All personal property of every kind, character and description owned by Seller and located on the Property and used in connection with the Property including, but not limited to all telephone numbers, all inventory of food, beverages, paper, chemical items, supplies, furniture, fixtures, equipment, carpeting, draperies, appliances, and the items listed on Exhibit A attached hereto and made a part hereof by this reference (collectively, the "Personal Property");
- (b) All leases, agreements, and contracts listed on Exhibit B attached hereto and made a part hereof by this reference, together with all of Seller's right, title and interest in and to all warranties in connection therewith (collectively, "Assigned Property"); and
- (c) All of Seller's right, title and interest in and to the trade name "The San Luis Resort and Conference Center", "The Inn at San Luis", "Sweetwater Apartments", "Sealy Manson", and "Stars" and the logos shown on Exhibit C attached hereto and made a part hereof by this reference together with all licenses, trademarks, registration and other evidence of Seller's ownership thereof (collectively, "Trade Name").

This Bill of Sale and Assignment is made subject to all Permitted Encumbrances, as that term is defined in that certain Earnest Money Contract dated November 16, 1995, by and between Seller and Purchaser.

From and after the date hereof, Purchaser shall assume all obligations of Seller in connection with the Assigned Property which arise after the date hereof and shall indemnify and hold Seller harmless from any and all claims, demands, liabilities, costs, expenses (including, without limitation, attorney's fees and cost), penalties, damages and losses (collectively "Claims") (i) resulting from Seller's assignment of the Assigned Property without the required consents and (ii) resulting from the Assigned Property after the date hereof. Seller shall remain liable for all obligations of Seller in connection with the Assigned Property which are incurred or arise on or prior to the date hereof, and shall indemnify and hold Purchaser harmless from any and all Claims resulting from the Assigned Property on or prior to the date hereof, except which may result from the assignment of the Assigned Property without obtaining the required consents. Purchaser shall remit to Seller any proceeds

received from the Assigned Property which were earned prior to January 1, 1996, and Seller shall remit to Purchaser any proceeds received from the Assigned Property which were earned on or after January 1, 1996.

TO HAVE AND TO HOLD the Personal Property, the Assigned Property and the Trade Name, together with all and singular the rights and appurtenances thereto in any wise belonging, unto Purchaser and its successors and assigns; and Seller does hereby bind itself and its successors and assigns to WARRANT AND FOREVER DEFEND all and singular the Personal Property unto Purchaser and its successors and assigns against every person whomsoever lawfully claiming or to claim same or any part thereof, by, through and under Seller, but not otherwise, subject to the Permitted Encumbrances.
