

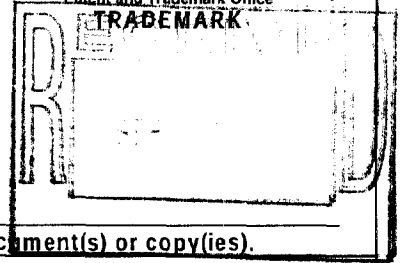

ASSIGNMENT OF TRADEMARK

WHEREAS Johnson Crushers International, Inc. ("JCI") is the owner of the trademark **JCI**, which is the subject of U.S. Trademark Registration Application No. 75/404637 (hereinafter referred to as "the Mark"); and

WHEREAS JCI adopted and used the Mark in connection with highway excavation equipment and mining equipment, namely rock crushers, vibrating screens and portable plants in the nature of wheel-mounted frames used to transport the rock crushers and vibrating screens, and replacement parts for the aforementioned parts (hereinafter referred to as "the Business"); and

WHEREAS JCI is a wholly-owned subsidiary of Astec Industries, Inc., a corporation organized and existing under the laws of the State of Tennessee and having a principal place of business at 4101 Jerome Avenue, Chattanooga, Tennessee 37407;


WHEREAS JCI, and Astec are engaged in a reorganization of certain of the relative rights and obligations of each to the other (hereinafter referred to as "the Reorganization"); and

WHEREAS, as a part of the Reorganization, Astec has acquired the Mark and the goodwill of the Business appurtenant thereto;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Johnson Crushers International, Inc. does hereby sell, assign and transfer to Astec Industries, Inc. all right, title and interest in and to the Mark, together with the goodwill of the Business connected with the use of and symbolized by the Mark.

Furthermore, JCI agrees that it will execute such other reasonable documents as are necessary to give effect to this assignment or to facilitate the recording thereof.
