CONFIRMATORY SERVICE MARK ASSIGNMENT

THIS ASSIGNMENT is made by and between Flag-A-Tag, a firm (partnership) organized under the laws of the State of Arizona, (hereinafter referred to as "Assignor"), and Porter C. Wilson, an individual d/b/a Flag-A-Tag Company, located and doing business at 5610 North Via Latigo, Tucson, Arizona 85704 (hereinafter referred to as "Assignee").

WHEREAS, Assignor is the record owner of the trademark FLAG-A-TAG, and the federal registration therefor, No.738,205 issued September 25, 1962 (hereinafter the "ASSIGNED MARK").

WHEREAS, on or about August 3, 1965, Assignor did assign to Assignee the ASSIGNED MARK including the federal registration therefor, the common law rights therein and the goodwill of the business associated therewith, but no formal assignment document in a form recordable in the Patent and Trademark Office was executed; and

WHEREAS, the parties hereby desire to reconfirm the prior assignment of the ASSIGNED MARK the federal registration therefor, and goodwill of Assignor associated therewith in order to record the change of the ownership in the Assignment Division of the Patent and Trademark Office and place formal title in the name of Assignee.

NOW, THEREFORE, for good and valuable consideration, previously paid by Assignee to Assignor, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign, set over and transfer unto said Assignee, nunc pro tunc, as of August 3, 1965, all right, title and interest in and to the ASSIGNED MARK and the federal registration therefor, the common law rights therein, together with the whole of the goodwill of the

business symbolized by the ASSIGNED MARK, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of the ASSIGNED MARK and with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives.

IN TESTIMONY THEREOF, said Assignor has caused its name to be signed by its duly authorized officer, this 8th day of April, 1999.
