This Trademark Assignment is made as of the 27th day of November, 1998, by Simon & Schuster, Inc., a New York corporation, having a principal business address at 1230 Avenue of the Americas, New York, NY 10020 ("Assignor"), in favor of Ahsuog Inc., a California corporation, having a principal business address at 1633 Broadway, New York, NY 10019 ("Assignee").


