

WHEREAS, said Assignor is the owner of U.S. Reg. No. 1,918,854 issued on September 12, 1995 for the STOREHORSE mark; and


WHEREAS, said Assignor is the owner of U.S. Reg. No. 2,018,994 issued on November 26, 1996 for the STORESTOOL mark.
