ARTICLES OF AMENDMENT

OF

Pursuant to the provisions of the Washington Business Corporation Act, Revised Code of Washington, Title 23B, the following *Articles of Amendment to Articles of Incorporation* are submitted for filing in accordance with RCW 23B.10.060.

ARTICLE I

The name of this corporation is ME TWO CORPORATION.

ARTICLE II

In accordance with the provisions of RCW 23B.10.020, the amendment to Article I, Name, of the *Articles of Incorporation* shall be as follows:

The name of the corporation shall be changed from ME TWO CORPORATION to MADISON PARK GREETINGS, INC.

ARTICLE III

The amendment provides for no exchange, classification or cancellation of currently issued shares.

ARTICLE IV

This amendment was adopted by the Board of Directors of the corporation on
