ASSIGNMENT OF  
TRADEMARK RIGHTS

THIS ASSIGNMENT is made as of the 28 day of December, 1998 by Husqvarna AB, a Swedish corporation having a principal place of business at Huskvarna, Sweden (the "Assignor") in favor of Viking Sewing Machines AB, a Swedish corporation having a principal place of business at S-561 81 Huskvarna, Sweden (the "Assignee"), pursuant to the terms of a Master Transfer Agreement dated April 10, 1997 between AB Electrolux, of which Assignor is a subsidiary, and AB Grundstenen 72906, under change of name to Swedish Sewing Machines AB, which corporation has subsequently changed its name to Viking Sewing Machines AB (Assignee);

WHEREAS, Assignor has adopted and used in the United States the registered trademarks listed in the Schedule attached hereto and is the owner of the registrations shown in said Schedule;

WHEREAS, Assignee wishes to acquire all of Assignor's rights in and to the trademarks identified in the Schedule hereto, including but not limited to the registrations for the marks (collectively, the "Trademarks");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign and transfer unto Assignee all rights, title and interest which Assignor has acquired in and to the Trademarks in association with the goods identified in the respective registrations, including the rights to sue for past infringement thereof, together with the goodwill of the business symbolized by and associated with the Trademarks, as well as the portion of Assignor's ongoing and existing business to which the Trademarks pertain.


Assignor further agrees that it will, at the request of Assignee, without additional consideration, execute any documents deemed necessary by Assignee:

- (a) to vest all rights, title and interest in the Trademarks in Assignee or any party designated by Assignee; and
- (b) to enable Assignee to seek, register, maintain or enforce rights in the Trademarks.
