
**ASSIGNMENT OF UNITED STATES TRADEMARK APPLICATION**

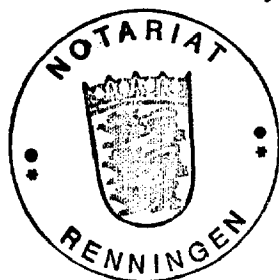


