Baker Petrolite Corporation, a corporation organized and existing under the laws of Delaware (the "Corporation"),

DOES HEREBY CERTIFY:

FIRST: That the Corporation was incorporated on the 6th day of December, 1930, pursuant to the Laws of the State of Delaware;

SECOND: That the Corporation owns all of the outstanding shares of the stock of Baker Performance Chemicals Incorporated, a corporation incorporated on the 7th day of June, 1951, pursuant to the Laws of the State of California.

THIRD: That the Corporation, by the following resolutions of its Board of Directors, duly adopted by unanimous written consent of its members, filed with the minutes of the Board on the 15th day of September, 1997, determined to and did merge into itself Baker Performance Chemicals Incorporated:

RESOLVED, That Baker Petrolite Corporation merge, and it hereby does merge into itself said Baker Performance Chemicals Incorporated and assumes all of its obligations; and


FURTHER RESOLVED, that the merger shall become effective on the 1st day of October, 1997; and

FURTHER RESOLVED, that the proper officer of the Corporation be and he or she is hereby directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge said Baker Performance Chemicals Incorporated and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in anywise necessary or proper to effect said merger.

FOURTH: Anything herein or elsewhere to the contrary notwithstanding, this merger may be amended or terminated and abandoned by the Board of Directors of Baker Petrolite Corporation at any time prior to the date of filing the merger with the Secretary of State.
