ASSIGNMENT OF U.S. TRADEMARK AND REGISTRATION

The undersigned hereby verifies and attests that he was a corporate officer of **ASSIGNOR** prior to said name change, that he is now a corporate officer of **ASSIGNEE**, and that he has the authority under Korean law to sign this document on behalf of **ASSIGNOR**.


