

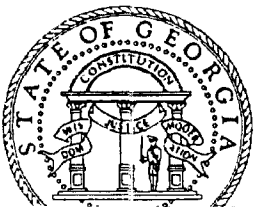

- (2) The text of each amendment adopted is:


The Certificate of Incorporation of Robarb, Incorporated be amended by changing the First Article thereof so that, as amended, said Article shall be and read as follows:
