2. Article I of the Articles of Incorporation of the Corporation shall be amended to read in its entirety as follows:

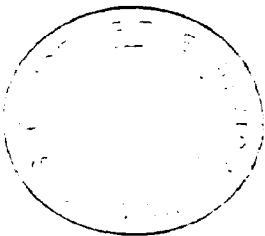

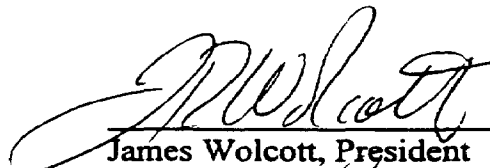
The name of this corporation is: On The Go Software, Inc."

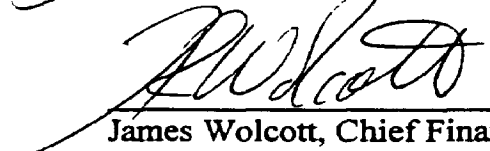
