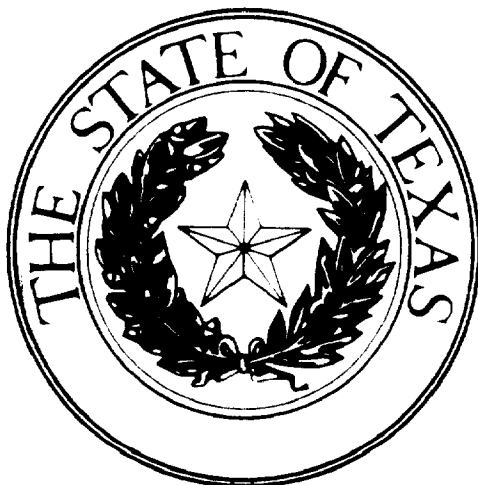



Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is REALPAGE COMMUNICATIONS, INC

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the Corporation's shareholders on December 15, 1998:

The Articles of Incorporation are amended by changing the following paragraph of Article First:

The name of the Corporation is RealPage, Inc. (hereinafter, the "Corporation").

ARTICLE THREE


