ARTICLES OF MERGER

REALPAGE COMMUNICATIONS, INC.

SEREN CAPITAL ACQUISITION CORP.

To the Secretary of State

Seren Capital Acquisition Corp., a corporation organized under the laws of the State of Texas, for the purpose of merging with another business entity, to wit, RealPage Communications, Inc., a corporation organized under the laws of the State of Texas, hereby certifies, pursuant to Article 5.04 of the Texas Business Corporation Act ("Texas Act"), that:

- 1. The name and jurisdiction of organization of each constituent business entity of this merger is as follows:

RealPage Communications, Inc.	Texas
Seren Capital Acquisition Corp.	Texas

- 2. An Agreement and Plan of Merger, ("Plan of Merger"), has been duly approved, adopted, certified, executed and acknowledged by Seren Capital Acquisition Corp. and RealPage Communications, Inc. by all action required by the laws under which it was incorporated or organized, by its constituent documents and in accordance with Article 5.01 of the Texas Act.

- 3 The surviving business entity pursuant to the Plan of Merger is Seren Capital Acquisition Corp.
- 4 There shall be no amendments or changes to the Articles of Incorporation of Seren Capital Acquisition Corp. as a result of the merger herein; provided, however, that as of the effective date of the Plan of Merger, the name of Seren Capital Acquisition Corp. shall be changed to "RealPage Communications, Inc."
- 5 The Plan of Merger is on file at the following place of business of the surviving business entity: c/o Seren Capital Acquisition Corp., 2395 Midway Road, Carrollton, TX 75006.
- 6 A copy of the Plan of Merger will be furnished by Seren Capital Acquisition Corp., the surviving business entity, on request, and without cost, to any shareholder of RealPage Communications, Inc. or Seren Capital Acquisition Corp.
- 7 Seren Capital Acquisition Corp. has 9,250,000 shares outstanding, and all such shares voted in favor of the Plan of Merger.
- 8 RealPage Communications, Inc. has 166.67 shares outstanding, and all such shares voted in favor of the Plan of Merger.
- 9 The surviving corporation will be responsible for the payment of all fees and franchise taxes of the merged corporations and will be obligated to pay such fees and franchise taxes if the same are not timely paid.

IN WITNESS WHEREOF, each of Seren Capital Acquisition Corp and RealPage Communications, Inc. have caused these Articles of Merger to be duly executed as of December 1, 1998.
