THIS ASSIGNMENT (the "Assignment") is made by GenCorp Inc., an Ohio corporation ("Assignor"), in favor of OMNOVA Solutions Inc., an Ohio corporation ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of the U.S. REGISTERED TRADEMARKS listed on Schedule 1.01(f) attached hereto (the "Trademarks"); and

WHEREAS, pursuant to a Distribution Agreement dated September 30, 1999 (the "Agreement"), between Assignor and Assignee, Assignor has agreed to sell, convey, transfer, assign and deliver the Trademarks along with the goodwill symbolized thereby to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, convey, transfer and assign to Assignee the Trademarks and all of Assignor's right, title and interest in and to the Trademarks, including, without limitation, (i) the goodwill of the business symbolized by the Trademarks and (ii) all rights to sue and recover damages for any and all past infringements thereof, all of the same to be held and enjoyed by Assignee for its own use and for the use of its successors or assigns as fully and entirely as the same would have been enjoyed by Assignor if assignment thereof had not been made.

This Assignment is given pursuant to the Agreement and is effective as of September 30, 1999 and is subject to the terms thereof and shall not be construed to limit, alter, impair, enhance or enlarge the rights and obligations under the Agreement and is given solely for purposes of separately evidencing the transactions contemplated thereby.


