TRADEMARK ASSIGNMENT NUNC PRO TUNC

WHEREAS, Handicomp, Inc., a Michigan corporation, having its principal place of business at 60 Baldwin St., Jenison, MI (hereafter "Assignor"), is the owner of record in the Patent and Trademark Office files of the entire right, title and interest in and to U.S. Trademark Registration No. 1,408,242 (registration date September 9, 1986) for the mark **HUMMINGBIRD** ("mark");

WHEREAS, Assignor has under a settlement agreement, having an effective date of May 11, 1995 assigned the equitable and legal title, together with the goods and the goodwill in the business in connection with the mark, to Michael M. Halprin and Marilyn L. Doig, residing at 2700 Beechwood Dr., S.E., Grand Rapids, Michigan 49506; and 415 South Howes #404, Fort Collins, Colorado 80521, respectively, (referred to as "Assignees"), and Assignees are and have since that time been owners of all right, title and interest in and to the mark, registration, and goodwill; and

WHEREAS, Assignees are desirous of acquiring, effective May 11, 1995, record title in and any and all remaining right, title, and interest that Assignor may have in and to the mark and the registration thereon, together with the goodwill of the business in connection with the mark is used and symbolized thereby, including all common law rights associated with the mark by virtue of its use in commerce, along with the right to recover for damages and profits for past infringement thereof;

WHEREAS, Assignor has agreed to assign and transfer its entire right, title and interest in and to the mark, together with all of the goodwill of the business in connection with the mark is used and symbolized thereby, including all common law rights associated with the mark by virtue of its use in commerce, along with the right to recover for damages and profits for past infringement thereof, to Assignees;

NOW THEREFORE, in view of the good and valuable and legally sufficient consideration, the receipt of which is hereby acknowledged by Assignor, Assignor does hereby sell, convey, transfer, assign and deliver effective May 11, 1995 unto Assignees, its successors

and assigns, the entire right, title and interest in and to the mark, the goodwill of the business in connection with the mark is used and symbolized thereby, including all common law rights associated with the mark by virtue of its use in commerce, along with the right to recover for damages and profits for past infringement thereof, and in and to any and all renewals thereof, to have and to hold forever for the sole and exclusive use and benefit of Assignees.
